### Choose the option that works best for you:

- Contract\* for specific sessions (cheapest per-session rate: \$15/session)
- Purchase coupon books\* good for any session (book of five coupons at \$18/session)
- Walk-on the sessions that you want (most expensive option: \$20/session)

**Contract Option:** Skaters may contract for specific approximately one hour-long sessions on CVSC ice. A minimum payment of \$100.00 must be submitted with the contract. Contracts will be processed in the order received. All previous ice bills must be paid in full before new contracts will be processed.

**Coupon Booklet Purchase Option.** Skaters may purchase books of 5 coupons good for any CVSC ice session with space available. Coupons are valid during the 2017-2018 ice season (Sept 3, 2017 to May 13, 2018) and are available to CVSC full and associate members only. The skater will be assessed a walk on fee if the coupon is not presented to the ice monitor. Coupons **will not** be replaced if lost and are not transferable.

\* Only full or associate CVSC members may purchase contracts or coupons. Membership forms may be found on the CVSC website <http://www.champlainvalleyskatingclub.org>. Contracts sent in by non-CVSC members **will not** be processed. **All skaters must have waiver and release forms on file in order to take the ice.**

**Walk-on Option:** The walk-on rate is **\$20 per session**. All walk-on skaters must be members of US Figure Skating or Basic Skills members of USFS. Priority is given to full CVSC members. Full CVSC members may register for walk-on sessions up to one week in advance with the ice monitor. (Note that reserved space is considered a contract and must be paid even if the skater does not skate during the reserved time).

### **MAKE UP SESSIONS/LOST COUPONS**

There are no make-ups for missed sessions. Lost coupons will not be replaced.

## **PAYMENTS**

A \$100.00 deposit must accompany this ice contract. Checks should be made payable to CVSC. Payments may be mailed to: CVSC Ice Coordinator, 12 Oakwood Lane, Essex Junction, VT 05452 or given to an ice monitor. **All contracts must be paid in full by March 1, 2018. Any member with remaining ice balances will be reported to USFS as required by USFS.**

## **ICE MONITORING**

Ice monitors make it possible for skaters to have their music played, they track attendance and make it possible for people to use coupons and walk-on to skate. Ice monitoring is also an easy way to support the club and get to know other skaters and families.

**New for 2017-2018 season – half price ice for ice monitors!**

We will select our ice monitors using a lottery system. Applications to ice monitor are due by Tuesday August 15, 2017 and the drawings will take place on Wednesday August 16, 2017. A skater (or parent) may enter the lottery one time for each session of ice contracted. A skater (parent) does not have to enter the lottery for the session of ice you have contracted for (ie, if the skater contracts for Sundays 1<sup>st</sup> session they could enter the lottery to monitor Sundays 2<sup>nd</sup> session). Ice monitors will receive the session of ice for which they are contracted for **HALF PRICE**. A skater (parent) may be selected to monitor only one session of ice unless there are open monitor spots available.

**Please note:** Ice monitors must commit to monitoring their selected session of ice for the entire regular season. Ice monitors will be required to sign an ice monitor contract and attend ice monitor training prior to the start of our season in September. If the ice monitor is unable to monitor a session it is their responsibility to find a trained ice monitor to cover for them. Failure to do so will result in a breach of the ice monitor contract and may result in their loss of ice compensation.

To enter the monitor lottery please see the last page of the ice contract and submit the application by August 15, 2017. Monitor duties may be performed by an adult family member or a skater at least 18 years of age.
