# CVSC Test Session Guidelines

1. A test application will be considered "on time" if the test chairperson receives it no later than **5 PM on the 'received by' date** listed on the application. An application that is late must include the late fee listed on the application **PER TEST**.
2. Applications will be processed in the order they are received. Postmarks are not used in this process. Please make every effort to get your application in **before** the deadline. Test sessions are sometimes full before the application deadline. The test chair will attempt to accommodate late arrivals but this is not always possible.
3. If there is insufficient ice time for all request or if judge availability limits the tests, the applications included in the schedule will be determined by date received within club affiliation:
  - CVSC
  - CVSC Associate Members
  - All others, in the order received
- a) This order applies as follows:
  - Applications received by the deadline will be scheduled first
  - Late applications will be scheduled as time permits and must include the late fee **PER TEST**
4. Tests are scheduled only after the test chair receives an application signed by the skater's coach, skater (parent if skater is a minor) and all fees are paid. If you are not a home club member of CVSC you **MUST** have a letter of permission from your home club Test Chair or club officer (President, Vice-President, Secretary or Treasurer).
5. Test fees will be refunded for cancelled tests only if the club is unable to get officials or sufficient ice time.
6. Skaters must be at the rink 60 minutes prior to their scheduled warm up time.
7. The only persons permitted to view the test results are the coach, skater and parents/guardians. A skater may choose to share their results with others but no one is allowed to view the results of other skaters without permission.
8. The club will post the test schedule on the web no less than 48 prior to the test date. In most cases, it will be posted 5 to 7 days before the test date.
9. Tests taken outside of a regularly scheduled test session at the request of a skater or coach are subject to an additional \$10 administration fee if accommodated (typically only tests that can be judged by a single official will be considered).
10. If a skater has a different primary coach for different disciplines (e.g., free skating, pairs, dance), the coach for each discipline the skater is testing must sign. A different form may be used for each and the \$10 application fee is paid only once per TEST SESSION.
11. Any partner who is over age 18 and partnering a minor on a pair or dance test must pass a background check (TR 36.03, 43.02, 51.04 effective July 1, 2017 in U.S. Figure Skating Rulebook). Skaters must indicate who will be partnering their test(s) on their application, if applicable. If there is more than one partner (e.g., pairs and dance partner), a different form may be used for each and the \$10 application fee is paid only once.
12. Effective November 1, 2017, Juvenile through Senior Free Skating, Pairs, and Partnered Free Dance tests (and Adult Gold FS test) may also be passed in IJS competition. Skaters must skate up to the next level (if allowed by the competition), achieve minimum scores, and obtain appropriate documentation as specified in TR 4.00 - 4.02 and Technical Notifications on the U.S. Figure Skating website (Technical Info section). Please send appropriate documentation to the test chair along with **\$20 processing fee** per test (checks payable to CVSC). The standard fees listed on the first page are not required for this method of testing.
